Your data will not be transferred to third countries and international organizations.

How long will your data be processed?

Your personal data will be processed by the Administrator for the duration of the agreement between the parties, for the period of pursuing any claims, i.e. 3 years from the date of the agreement termination between the parties, as well as for archival and settlement purposes specified in specific provisions such as tax law and the Accounting Act (in the case of accounting documents, for a period of 6 years).

What are your rights?
